Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 3 (One sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 18 of which not more than 1/3rd sections may be used for senior secondary classes. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. The maximum number of students in a section should not exceed 40.
2	Only one CWsN toilets is seen. Thus, the school must ensure of construct CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.
3	Ramp at entrance as well as to access upper floor is not seen clearly in the video. Thus, the school must ensure of availability of Ramp at entrance as well as ramp/ lift to access

	upper floors with proper incline and safety features as per the provisions laid down in RPWD Act and Board's guidelines within 03 months and submit the compliance
4	Storage should be separate room or covered racks with restricted access instead of cabinets under work stations in all the lab (Composite/Physics/Chemistry/Biology), which constrain movement of students and are unsafe. The school shall upgrade all the lab as per SoP issued by the board within 3months and submit compliance on SARAS with videography
5	More workstation needs to be added in Math lab. The school should procure more learning aids/kits in the Math Lab and upgrade the lab as per SoPs issued by the Board and submit the compliance through videography within 3 months on SARAS portal.
6	The school shall conduct training of its teachers with CoE Prayagraj (Allahabad) within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6.
